

Health Services Act 2016

**Instrument of Delegation and Authorisation
by
CHILD AND ADOLESCENT HEALTH SERVICE**

The Child and Adolescent Health Service, being a body corporate established under section 32 of the *Health Services Act 2016*, hereby:

1. revokes all previous delegations to, and authorisations of, staff of the Child and Adolescent Health Service in relation to the delegations and authorisations covered by this instrument;
2. pursuant to section 40 of the *Health Services Act 2016*, delegates to the person/s occupying the class of position in column 5 of the Schedule the functions of the Child and Adolescent Health Service listed in column 2 of the Schedule, subject to the conditions or restrictions (if any) listed in column 4 of the Schedule, in relation to the following item numbers in column 1 of the Schedule:

3. authorises the person/s occupying the positions in column 6 of the Schedule (or any person acting in a higher tier class) to carry out the function, power or activity of the Child and Adolescent Health Service listed in column 2 of the Schedule, subject to the conditions or restrictions (if any) listed in column 4 of the Schedule, in relation to the following item numbers in column 1 of the Schedule:

PR 1.01, LM 3.01, LM 4.01-4.02, RA 1.01

4. pursuant to section 41(7) of the *Health Services Act 2016*, authorises the person/s occupying the class of position in column 5 and 6 (or any person acting in a higher tier class) to execute deeds or other documents on behalf of the Child and Adolescent Health Service as required to carry out the function, power or activity described in column 2 of the Schedule allocated to their class of position, subject to the conditions or restrictions (if any) listed in column 4 of the Schedule.

This instrument takes effect on the date it has been executed and remains in force until otherwise amended or revoked.
